




Impact of COVID-19 on business across next six months



A slow down in ASEAN economic integration is predicted




Will the pandemic slow down economic integration in ASEAN?

If there is a slowdown in economic integration in ASEAN, would that be bad for your business?






Impact on Existing Trade Barriers

- Consumer goods and ICT were most concerned about time and cost of import/export procedures






Businesses have adopted more efficient working practices and experienced greater staff productivity


